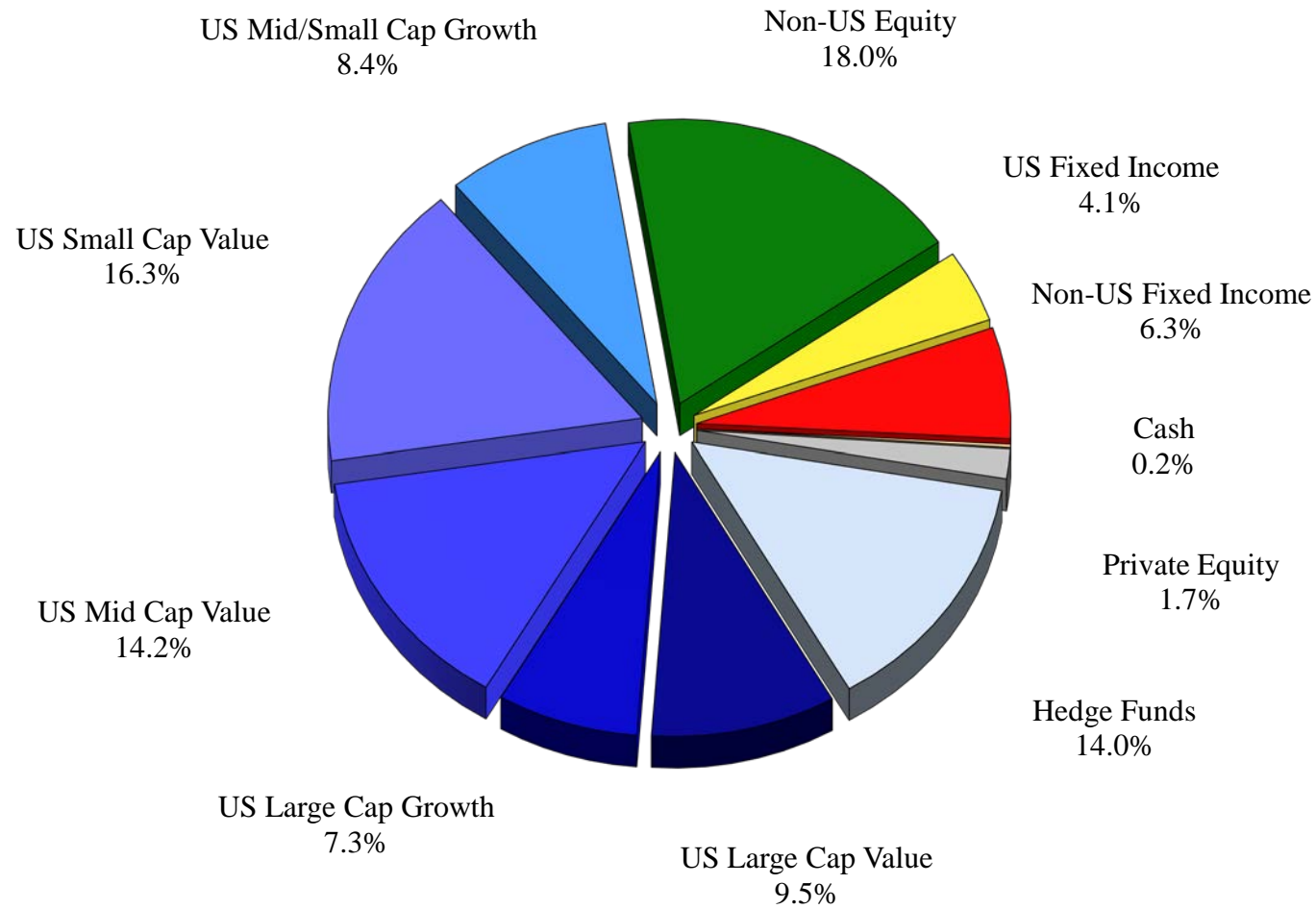

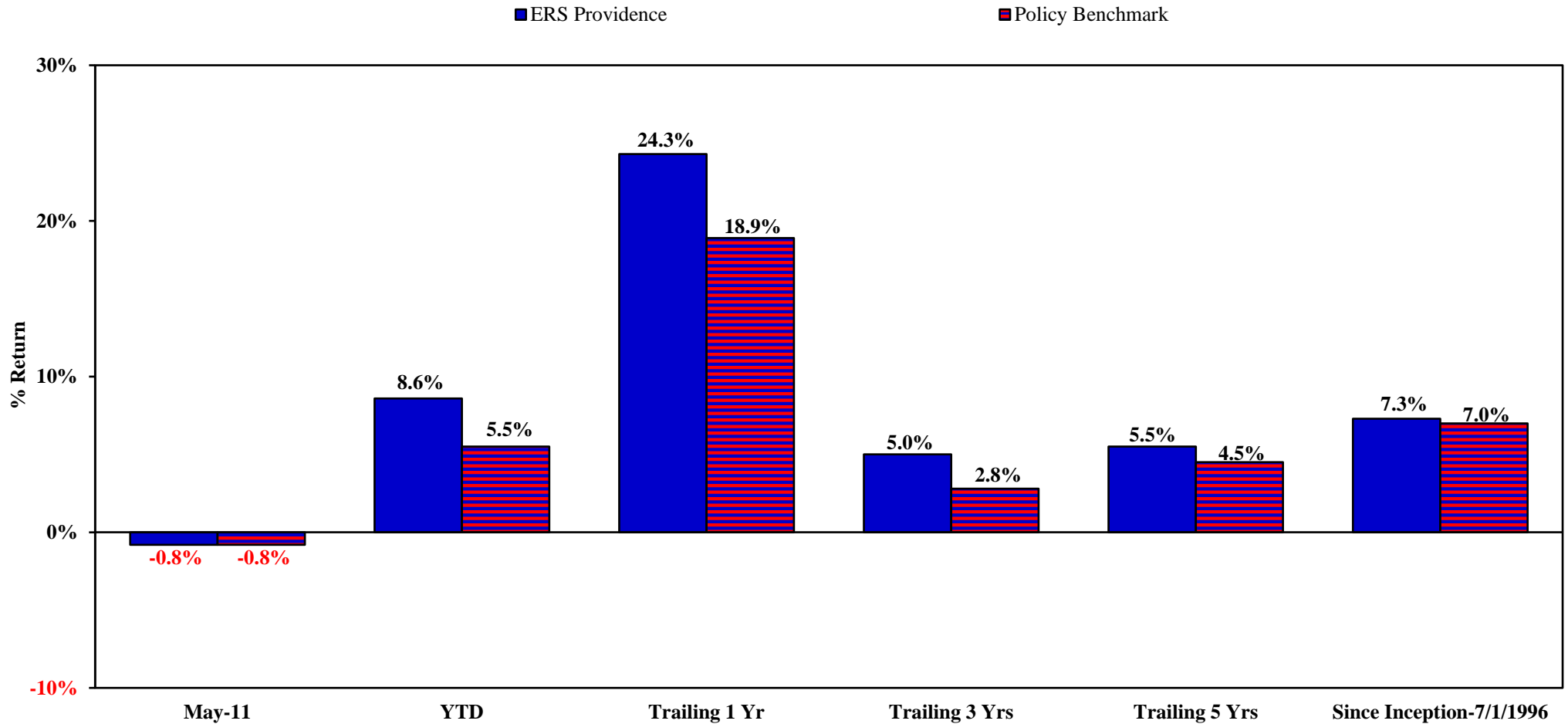
Investment Policy/Asset Allocation at May 31, 2011

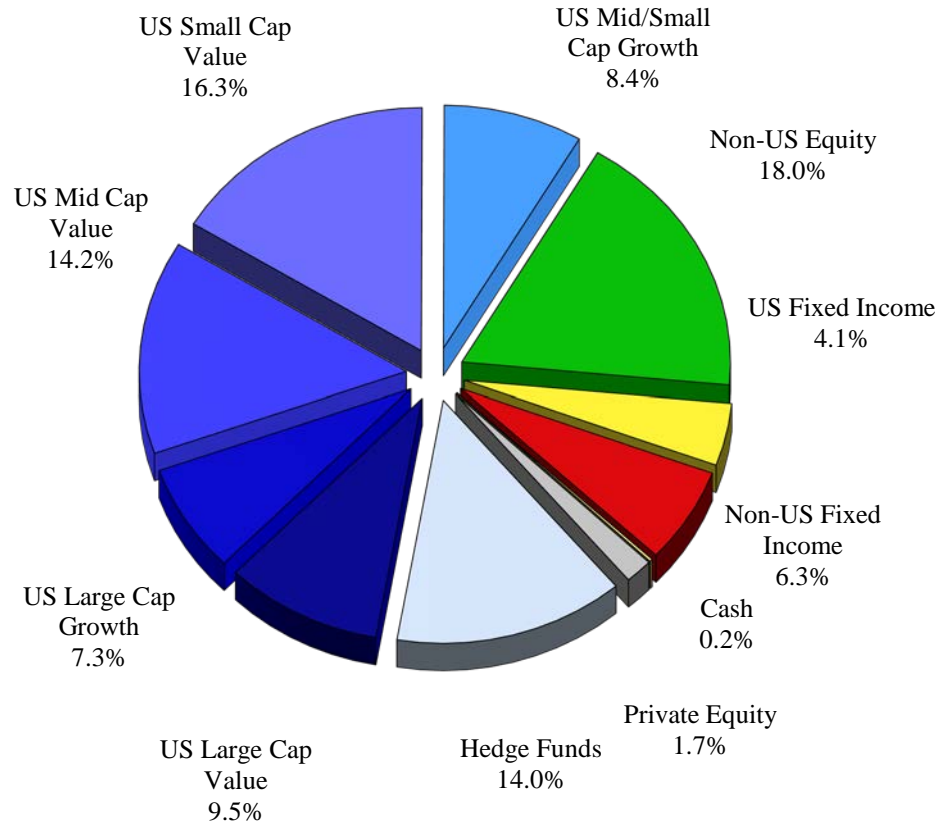

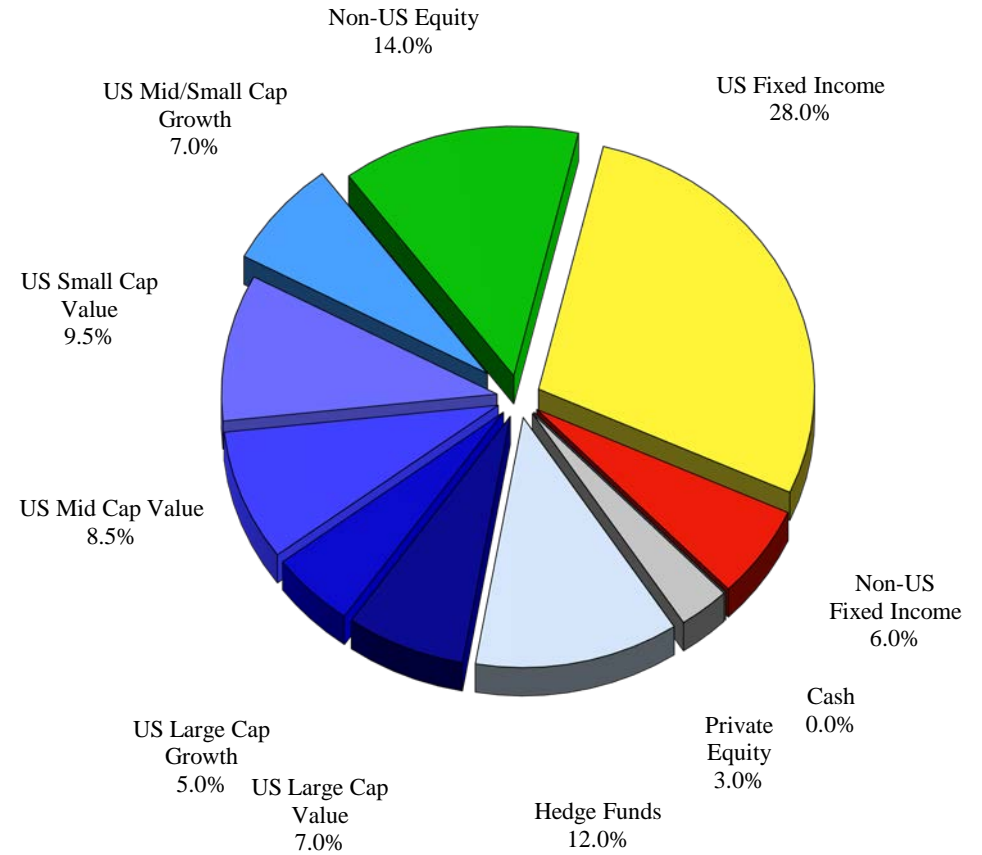

May 31, 2011



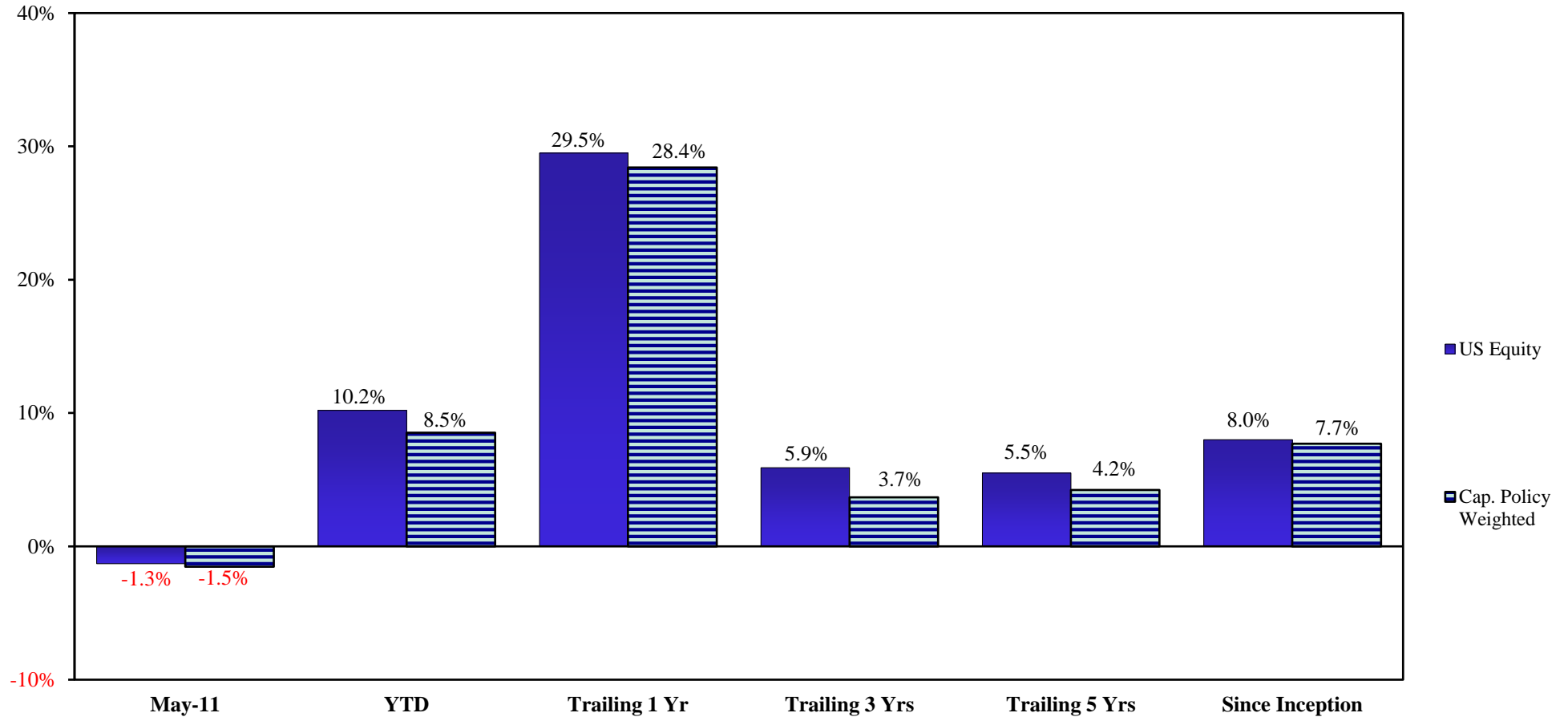
New Investment Policy/Asset Class Mix

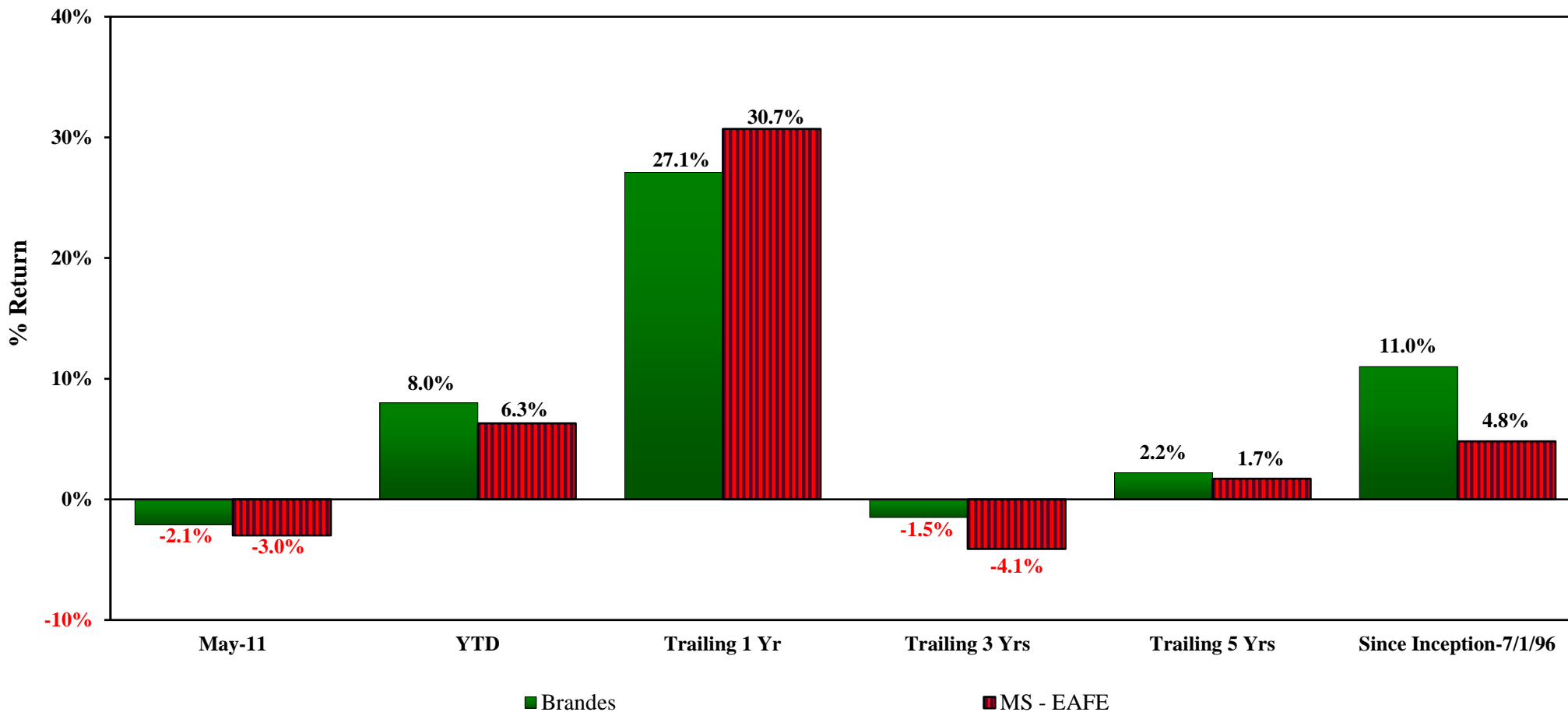

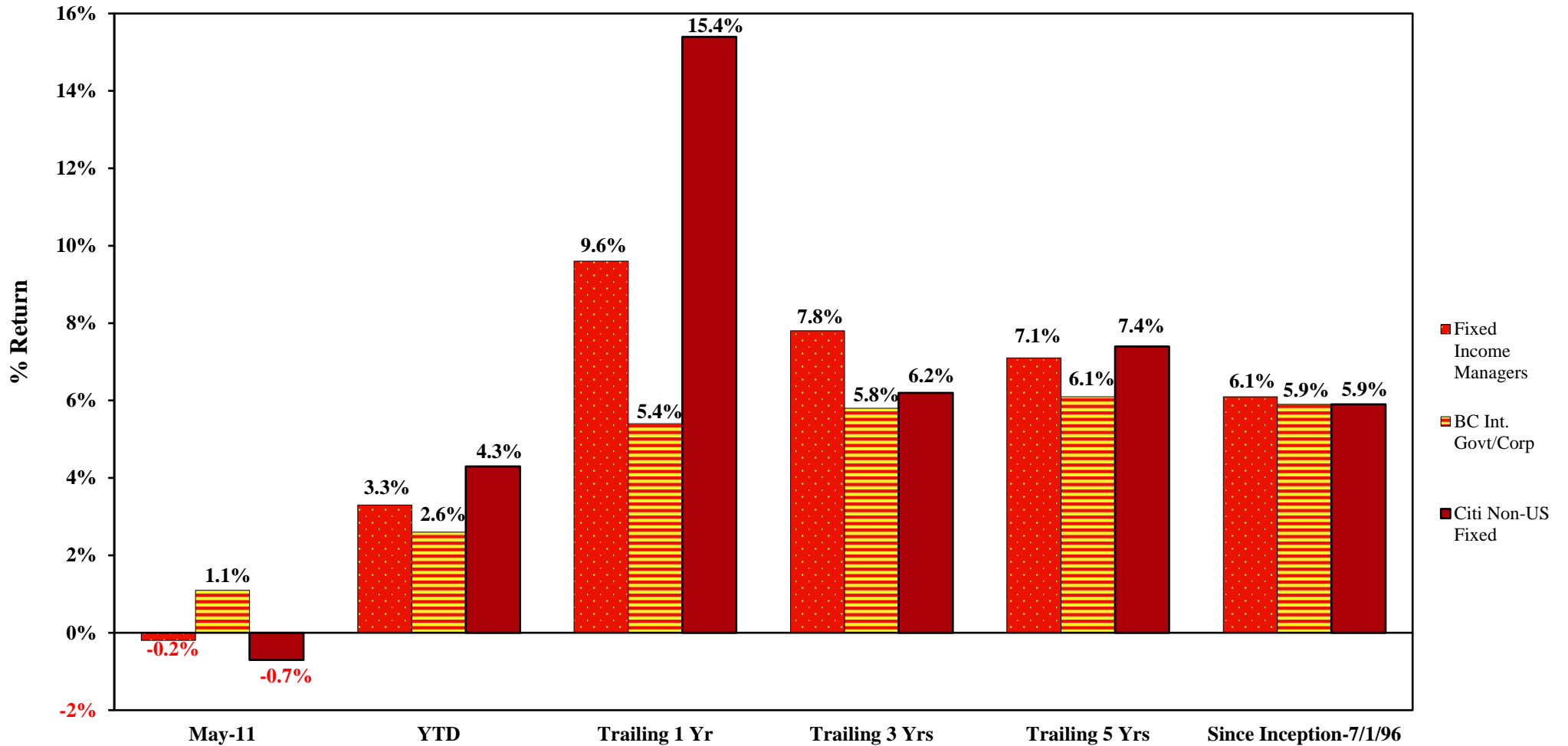

Fixed Income Managers Performance

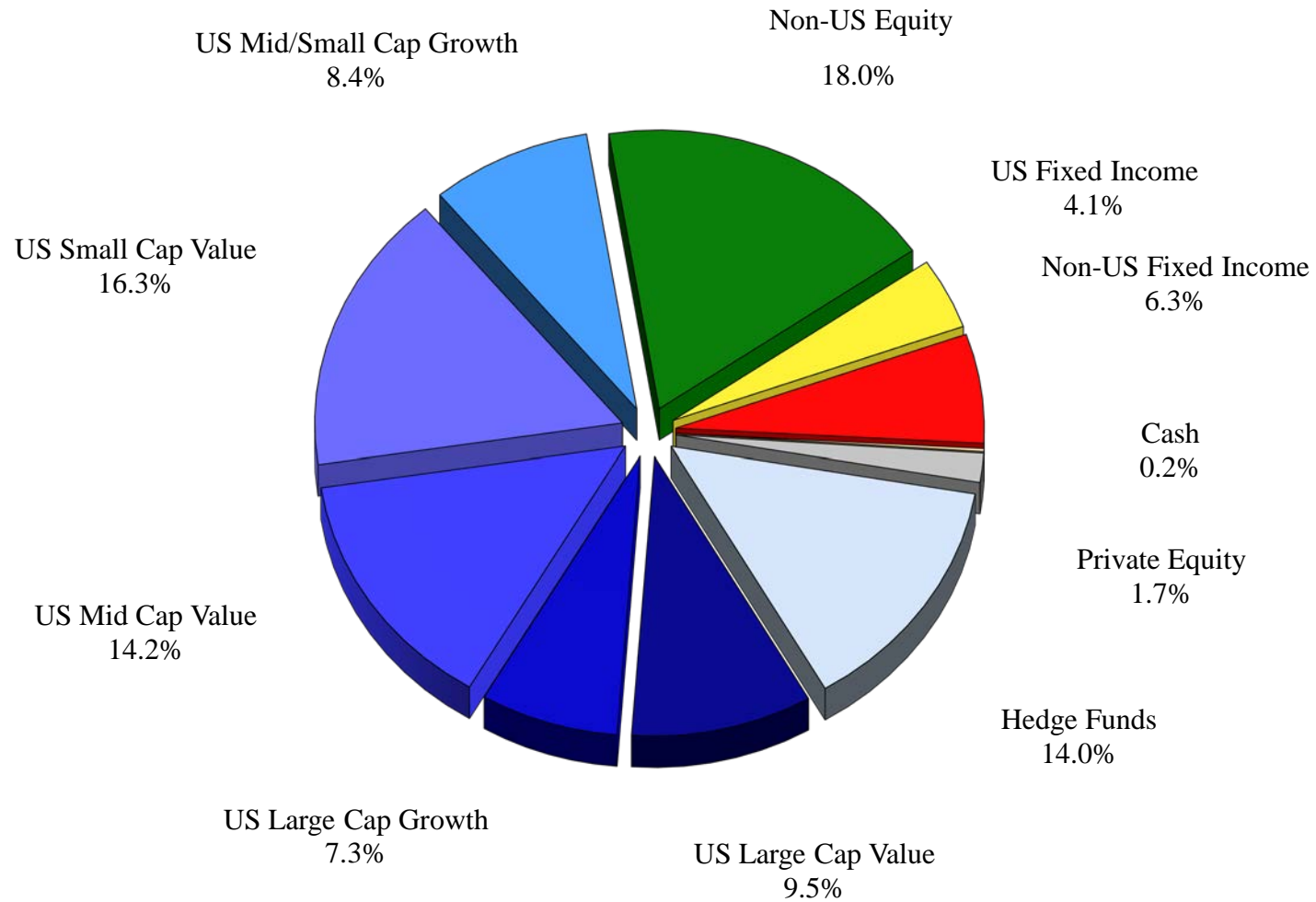
Total Fixed Income

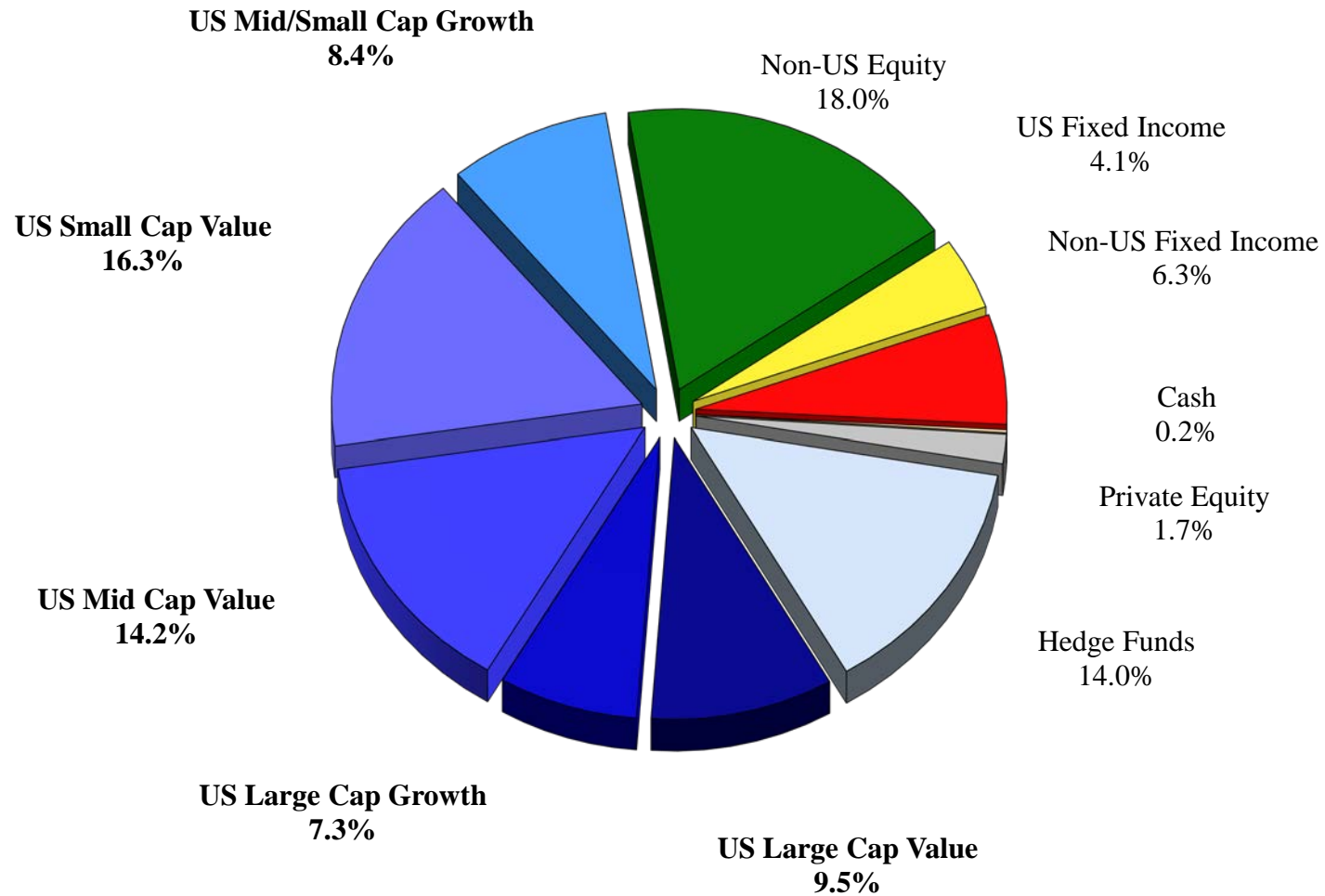

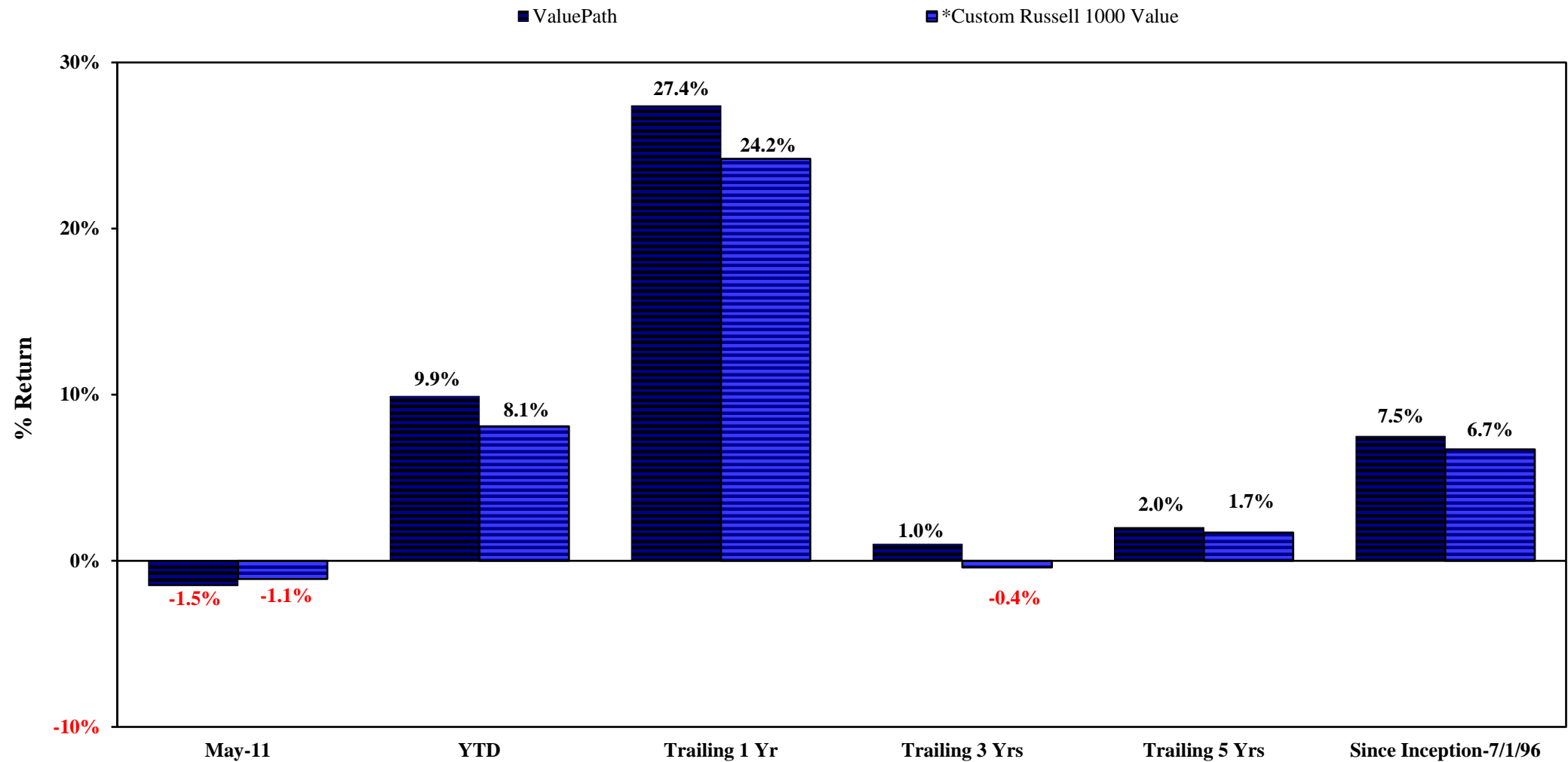

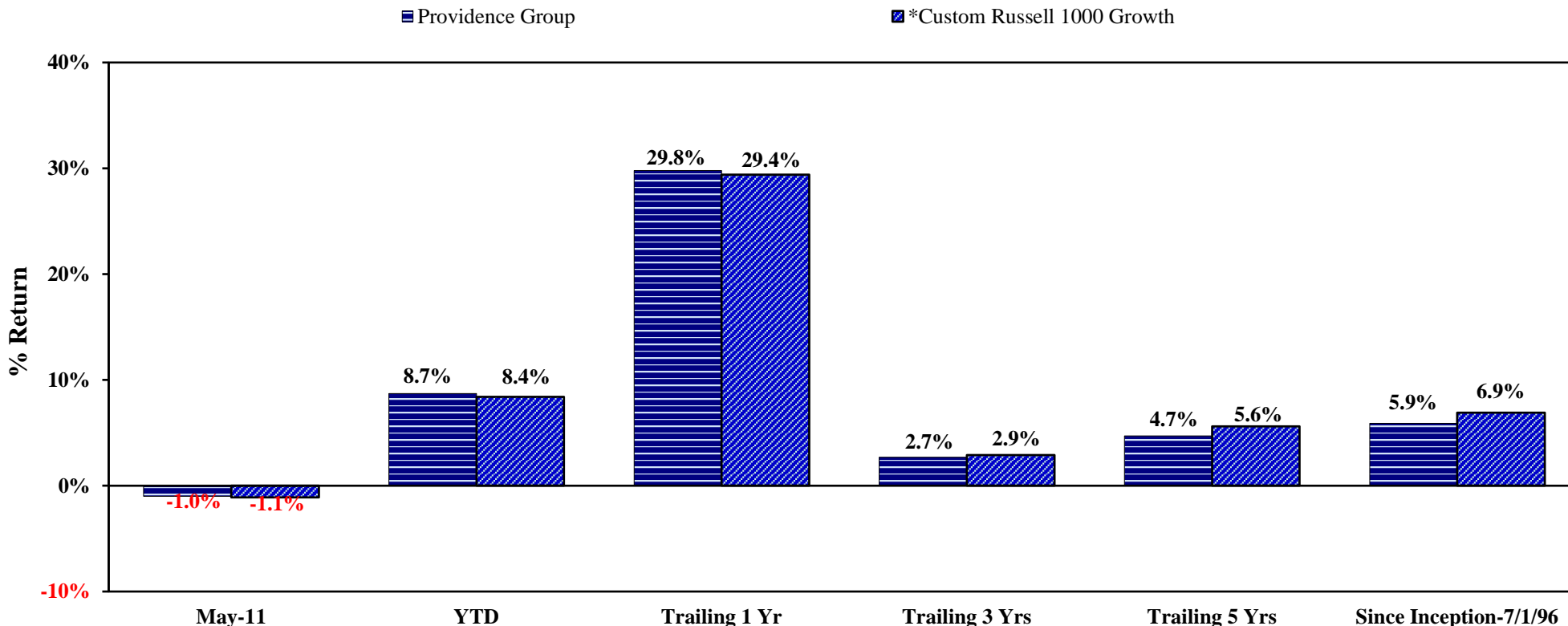

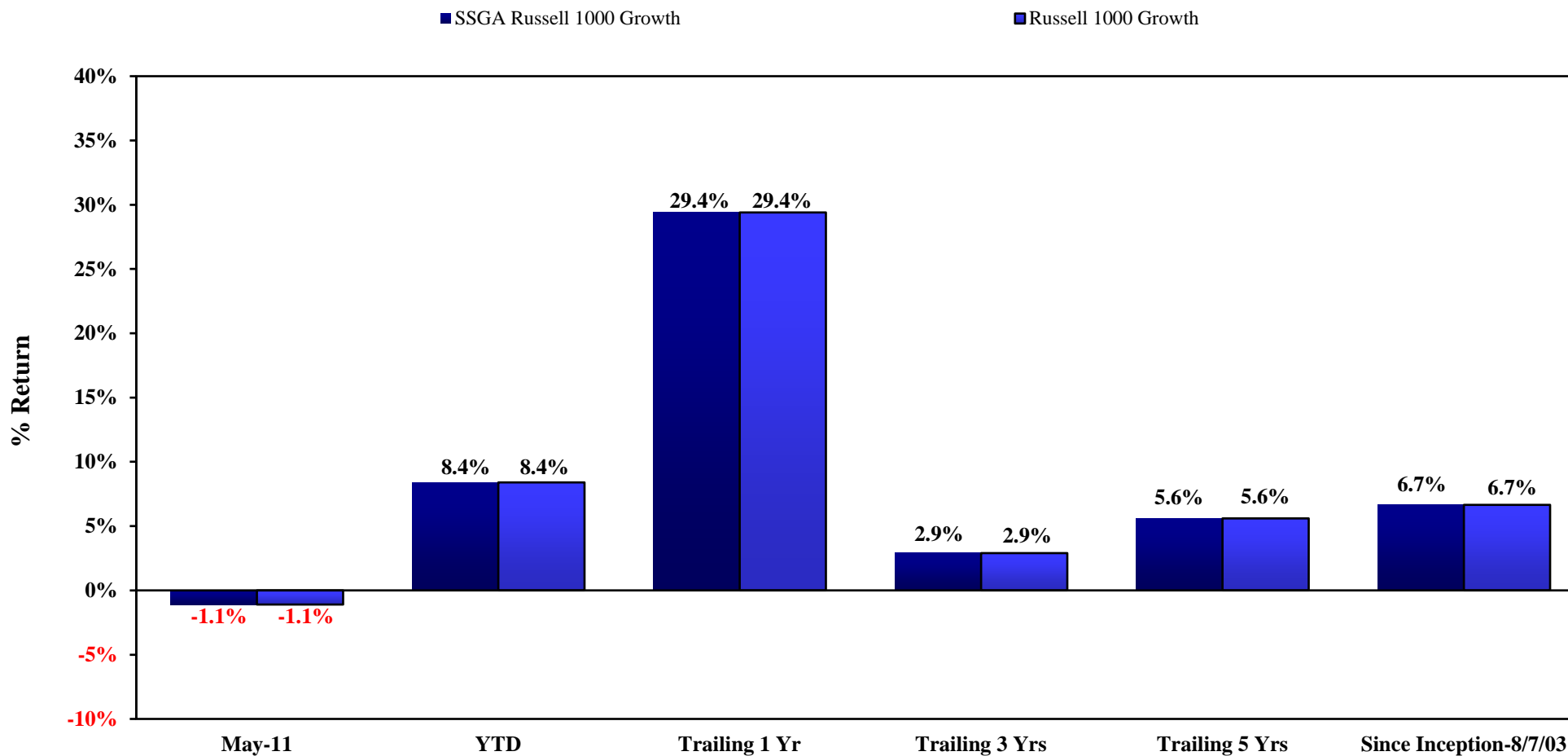

SSGA Russell 1000 Growth



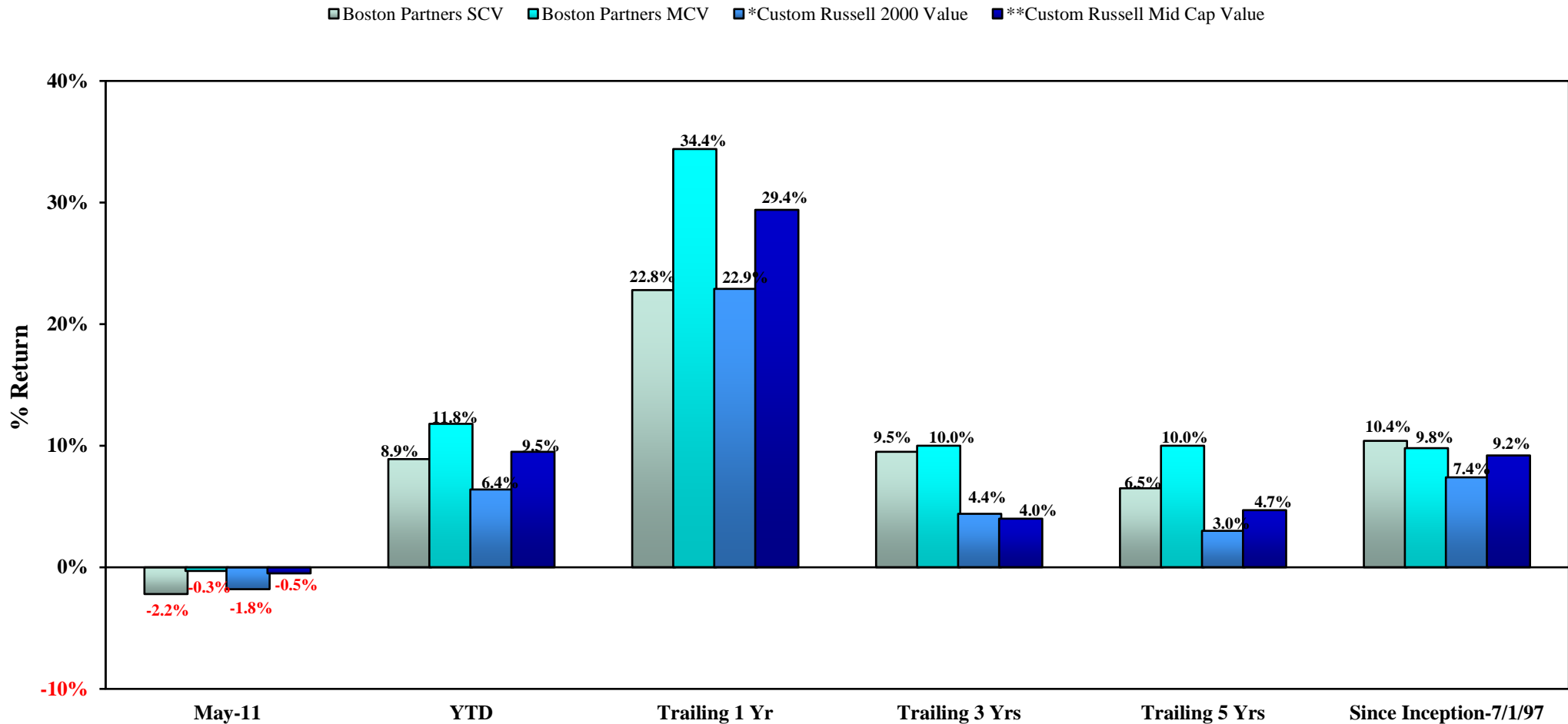

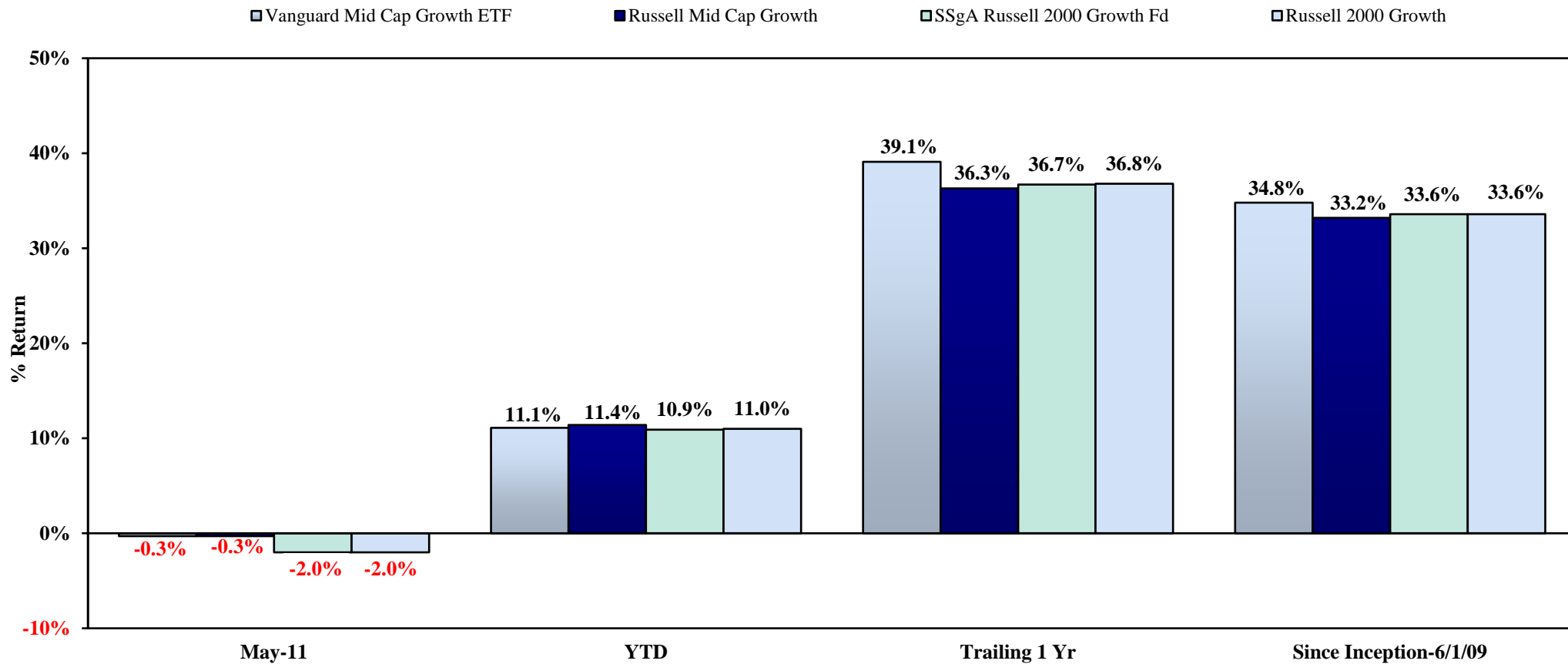

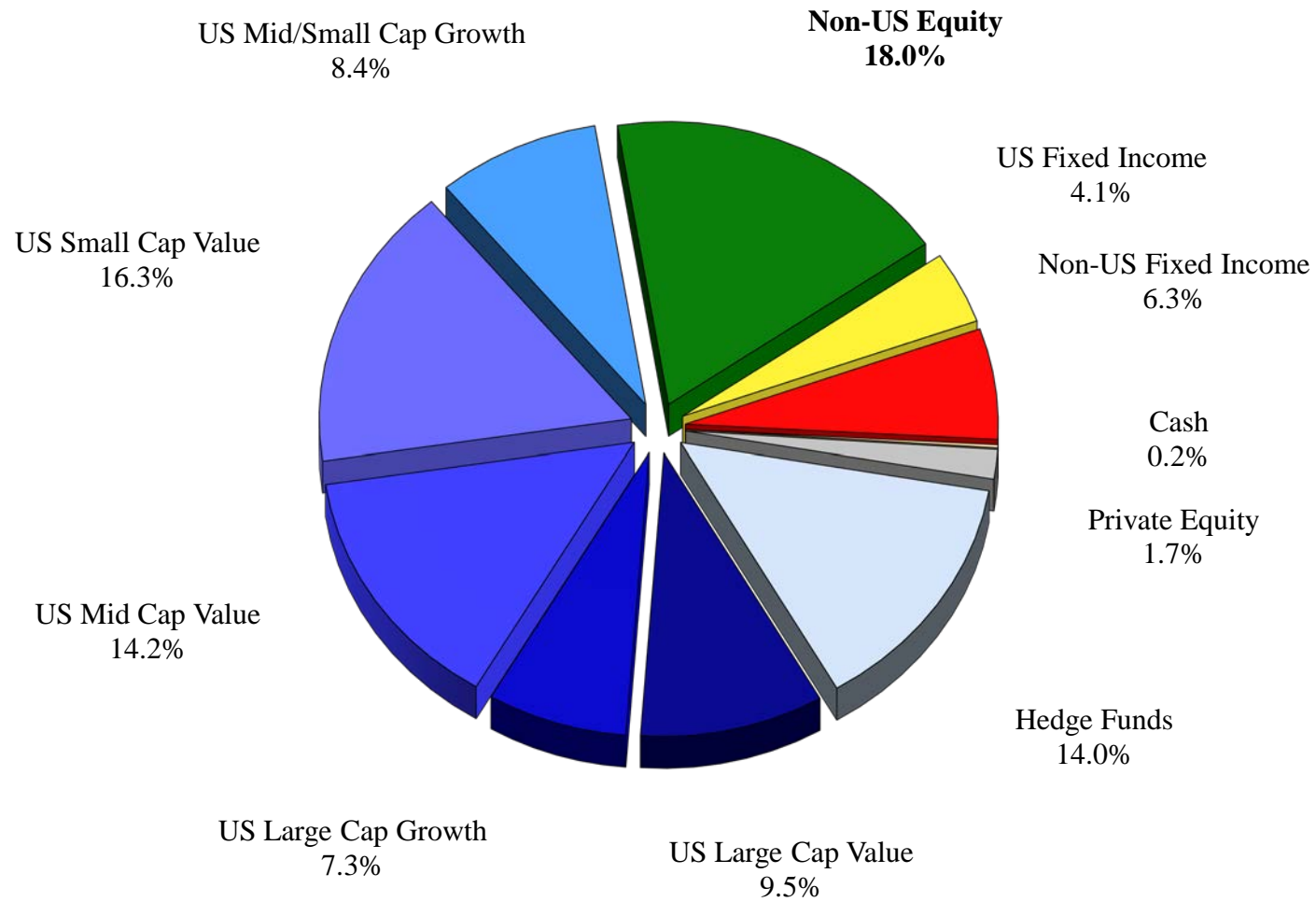

Brandes Investment Partners vs. EAFE

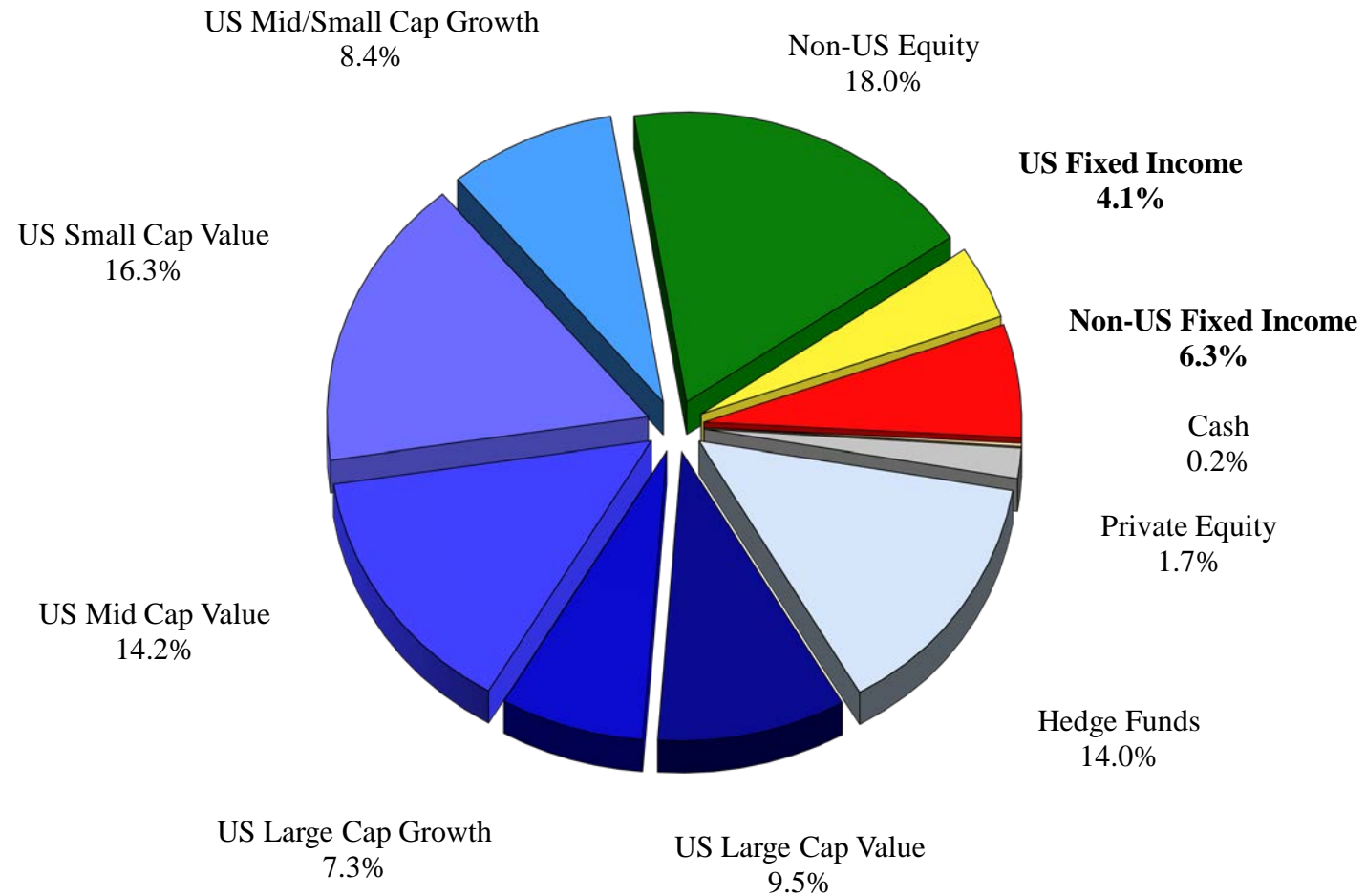

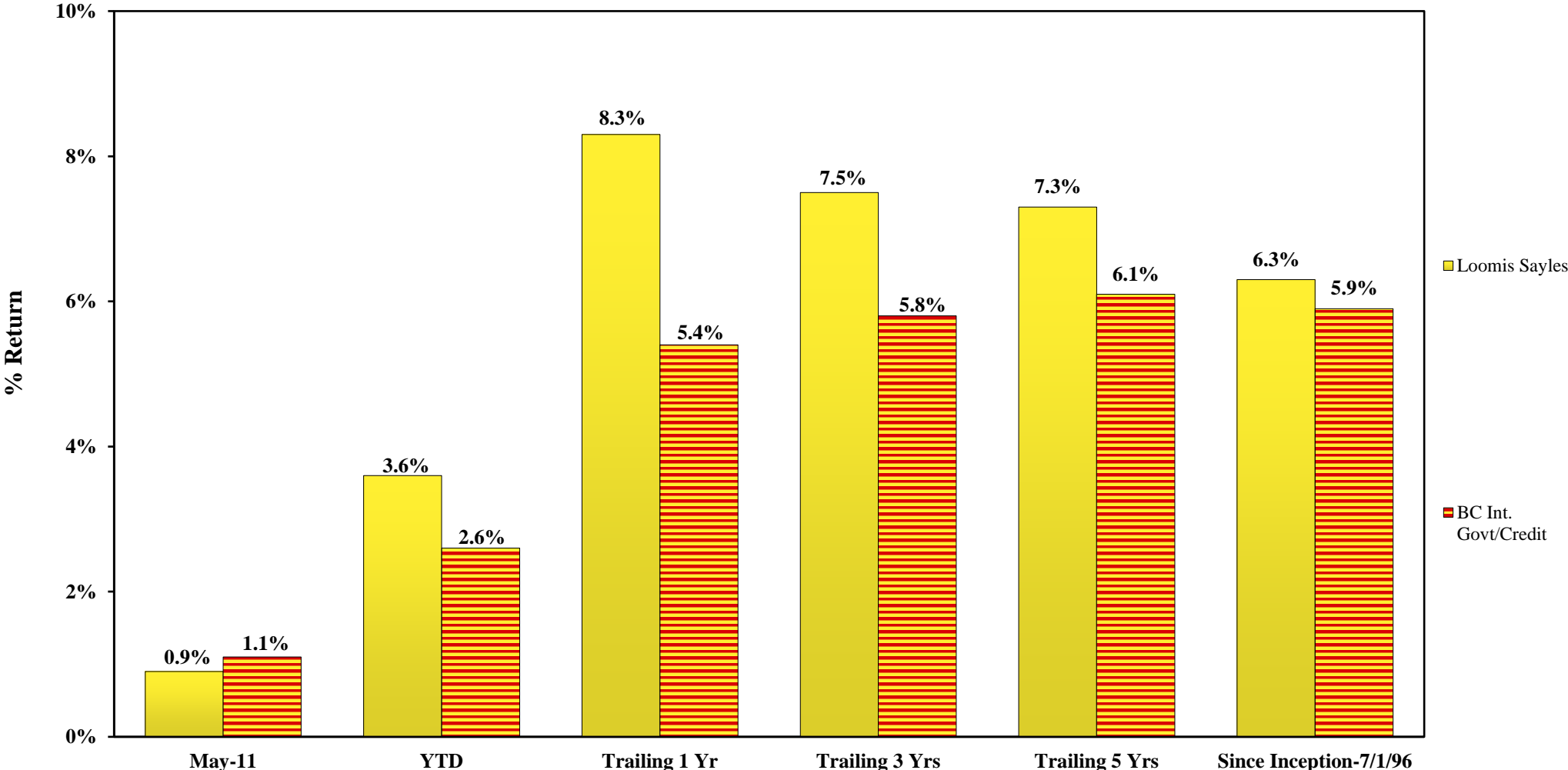

Loomis - US Fixed Income



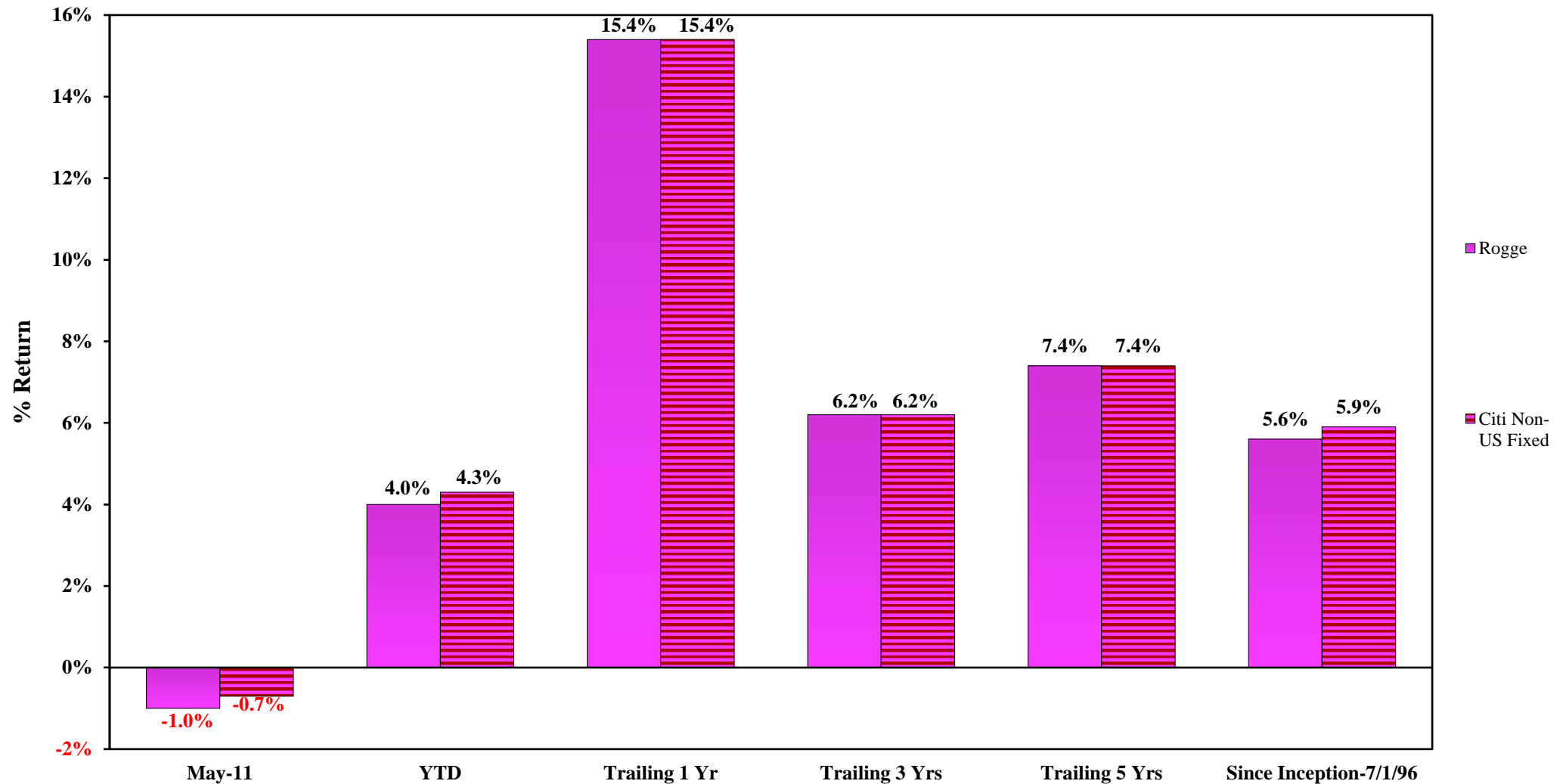

Rogge - Non-US Fixed Income

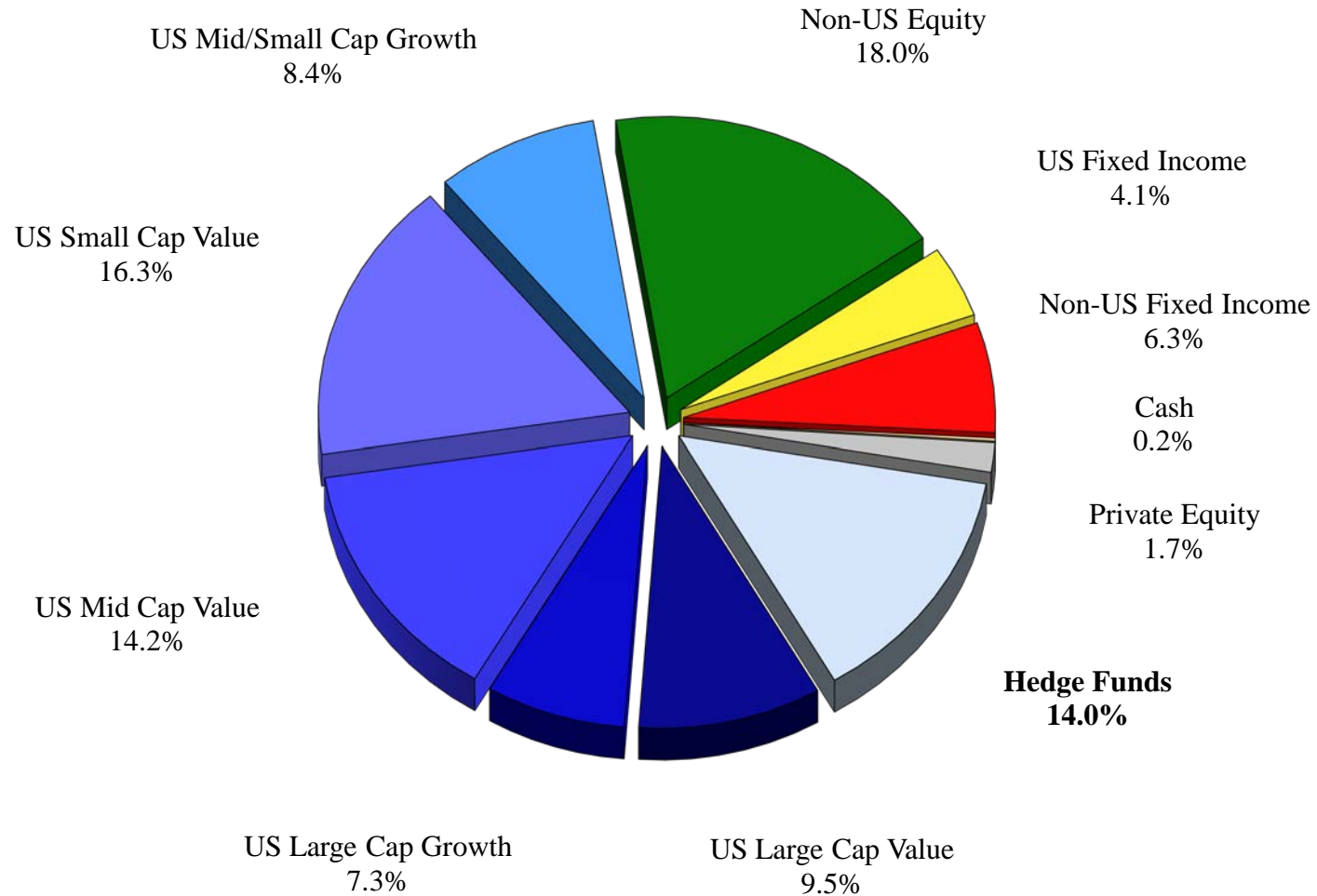

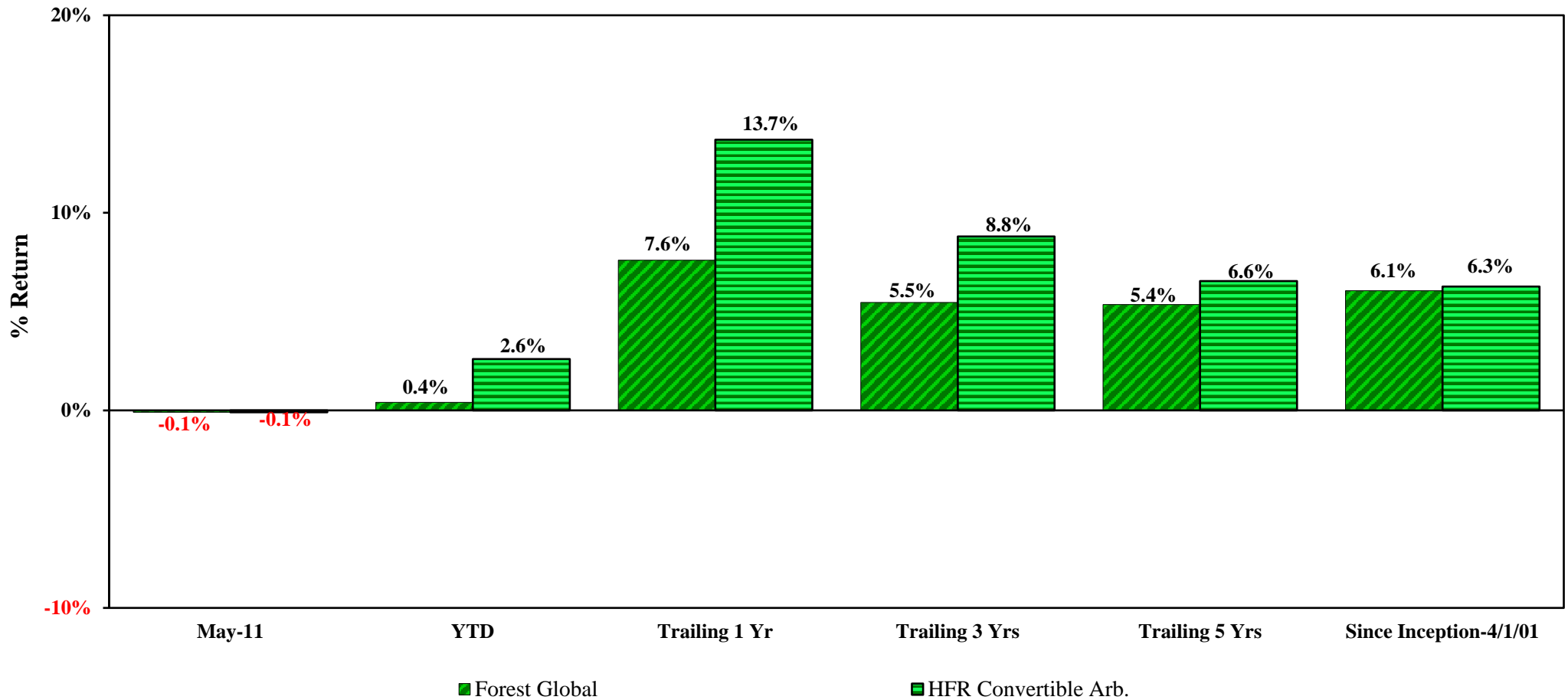

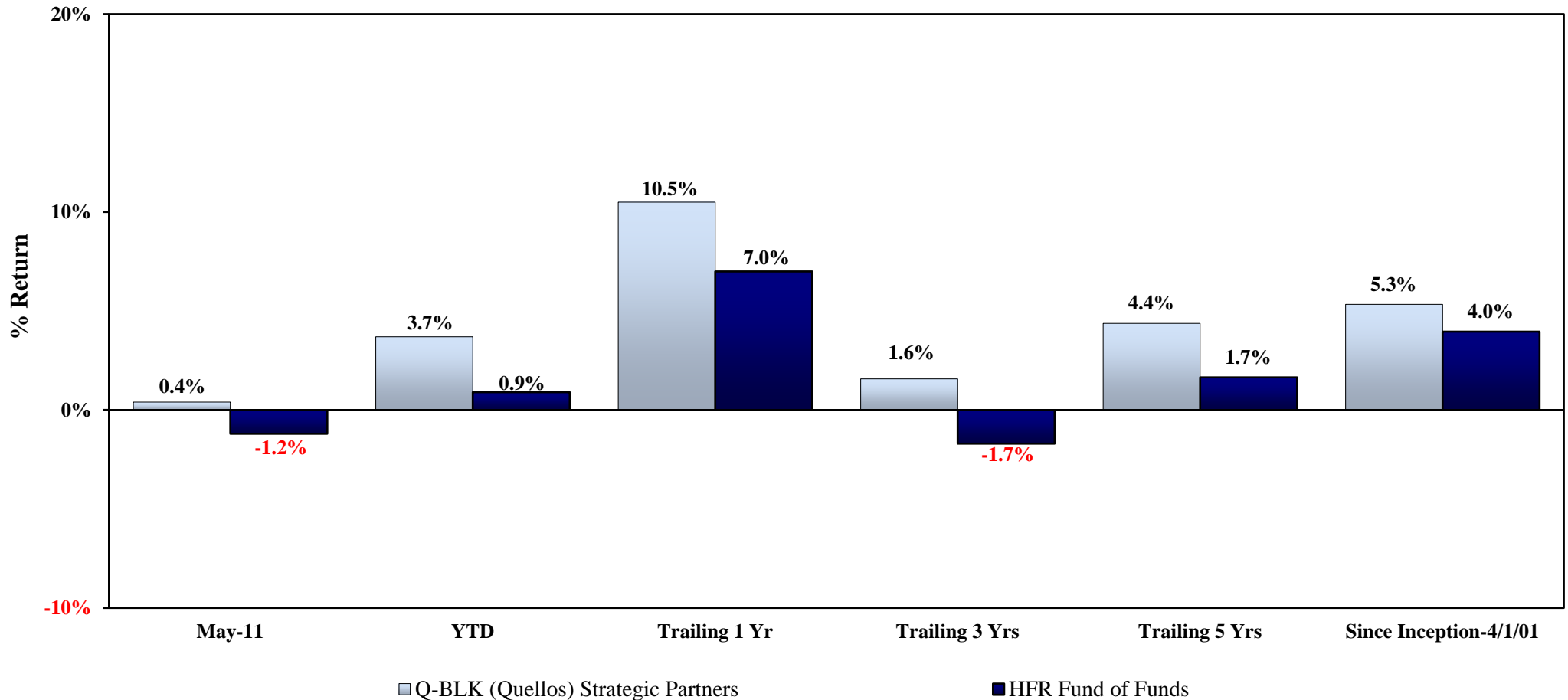

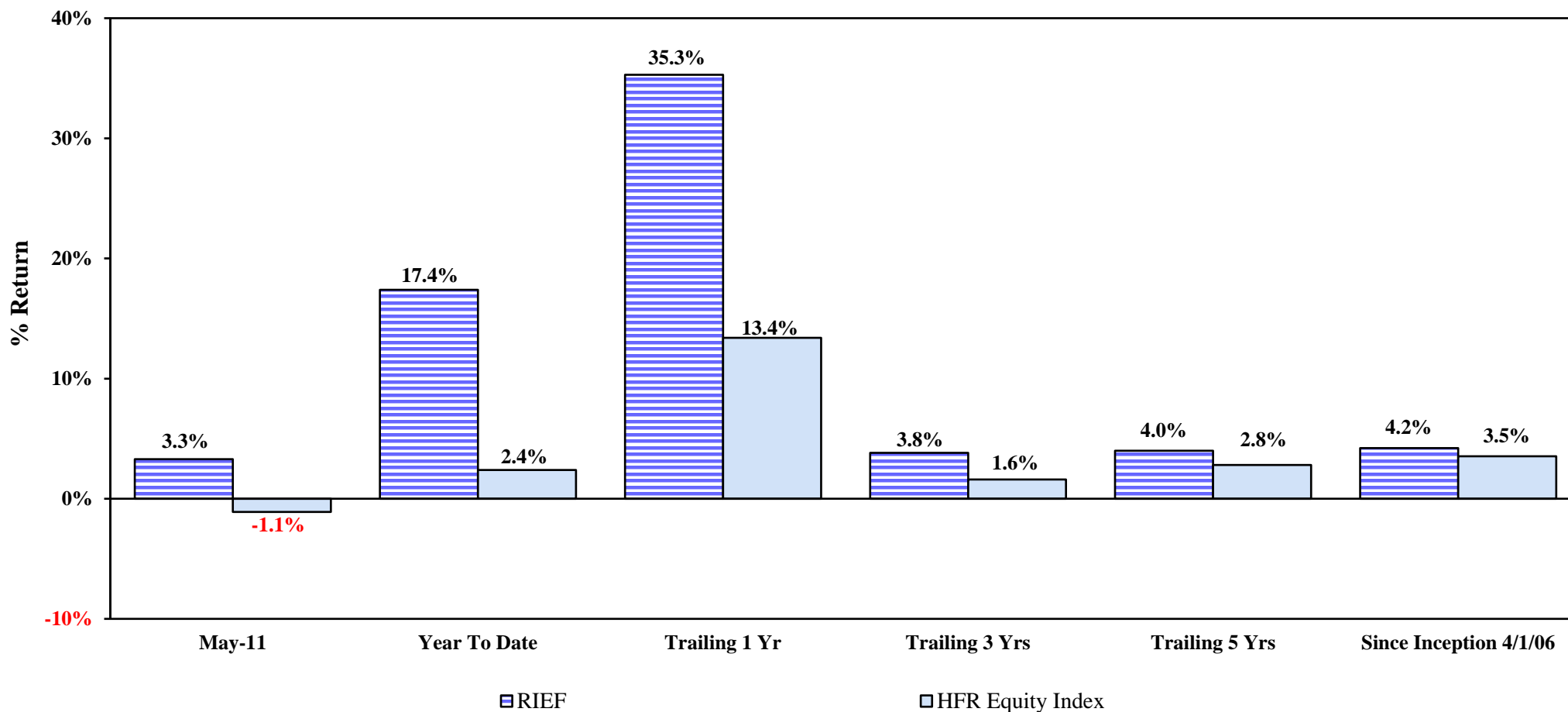
